ORDER:

In the G.O 1st read above, orders were issued to authorize the powers to various officials of their respective jurisdiction to fix the speed limits on National Highways/State Highways/Major District Roads/Other District Roads in consultation with the local Police and Transport Departments, to restrict the speed limit of motor vehicles in the interest of public safety or convenience or because of nature of any road or bridge. Accordingly, the Superintendent Engineers of Greater Hyderabad Municipal Corporation are authorized to fix Speed Limits on roads of GHMC under their jurisdiction.

2. In the letter 2nd read above, the Joint Transport Commissioner, O/o the Transport Commissioner, Telangana State, Hyderabad, has requested the Government to notify the Speed limits in all Zones of Greater Hyderabad Municipal Corporation (GHMC) based on type of roads and type of vehicles as fixed by the Superintendent Engineers of Maintenance Wing, Greater Hyderabad Municipal Corporation (GHMC).

3. Accordingly, the following Notification shall be published in the Extra-ordinary issue of the Telangana Gazette,dated:25.05.2022.

NOTIFICATION

In exercise of the powers conferred by sub-section (2) of section 112 of Motor Vehicles Act, 1988 (Central Act No.59 of 1988), the Government of Telangana hereby fixes the maximum speed in respect of the class of Motor Vehicles in Greater Hyderabad Municipal Corporation area as specified in the table below in the interest of public safety or convenience or because of nature of any road or bridge is as follows:

2.	Other Vehicles (Goods vehicles, buses, three wheelers, Motor Cycles etc.)	50	40	30

Nothing in this section shall apply to any vehicle registered under section 60 while it is being used in the execution of military manoeuvres within the area and during the period specified in the notification under sub-section (1) of section 2 of the Manoeuvres, Field Firing and Artillery Practice Act, 1938 (Central Act No.5 of 1938).
